- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2077-10-27 at the office of Panchkhapan Municipality, Wana, Sankhuwasabha. Bids must be valid for a period of 30 Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs. 3,75,000, which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date.
