- The Government of Nepal [GoN] & Panchkhapan Municipality has allocated funds from GoN & Panchkhapan Municipality towards the cost of Bihibare–Wana-Lingling- Badereni Road Construction Project and intends to apply part of the funds to cover eligible payments under the Contract for identification number: PMW/SS/RUP/B-W-L-B/03/78/79 Bidding is open to all eligible as per Section V of bidding document.
- 2. **The Panchkhapan Municipality** invites electronic bids from eligible bidders for the construction of **Bihibare-Wana-Lingling-Badereni Road Construction Project**, under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 3,98,00,000/-
- Minimum Work experience of similar size and nature: At least 2 (Two) Road construction Contracts within the last 10 years, each with a value of a least *NRs. 2,12,64,000/-* that have been successfully or are substantially complete.
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Panchkhapan Municipality*, *Wana,Sankhuwasabha*or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. A complete set of Bidding Documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp.Bidders Should deposit the cost of NRs. 5000/- on or before 2078/07/23 for bidding documents in the projects Aantarik Rajaswa(revenue) account as specified below and the scanned copy (PDF fromat) of the bank deposite voucher shall be uploaded by the bidder at the time of electronics submission of the bids.

- Electronic bids(one technical bid and other price Bid) must be submitted through PPMO's e-GP system <u>www.bolpatra.gov.np/egp</u> on or before 12:00hrs on 2078/07/24(10th Nov, 2021). Bids received after this deadline will be rejected.
- 7. The Technical bid will be opened electronically in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 2078/07/24(10thNov,2021) at the office of Panchkhapan Municipality, Wana, Sankhuwasabha. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,amounting to a minimum of NRs 7,00,000.00/- which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
