- The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs on 2077-12-18** at the office of **Panchkhan Municipality, Wana, Sankhuwasabha**. Bids must be valid for a period of **30 Days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Rs. 3,57,500.00**, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date.
